Vendor locations can accommodate 10X30 tent or trailer (this includes hitch). Hook-up for electricity is available up to 50 amps upon request prior to the event. Water source is available; however, direct hook-up is not. Tents, tables and chairs will not be provided. All food vendors will be assigned an arrival time on Friday, June 14<sup>th</sup>. Please be aware of heavy traffic when loading and unloading.

Early arrivals will not be accommodated.

**Any vendor selling food items is considered a food vendor and must complete this form.**

**Certificate of Insurance, Food/Beverage License and List of Menu Items are required with this application. NO EXCEPTIONS.**

Limited space for food vendors. Application will be processed on a first come, first served basis and must accompany full payment to be considered. Locations and spaces for vendors are at the discretion of the Okie Noodling Committee.

1. The booth will only be used for the purpose described above by the occupant. Any other use of the booth (i.e., sharing with another unnamed occupant) is prohibited.
2. Occupant agrees to keep the booth and the immediate area around the booth clean and neat at all times during the Okie Noodling Tournament.
3. Occupant agrees to properly dismantle their booth at the end of the Okie Noodling Tournament, or at such time the occupant decides to cease operation of the booth. Occupant also agrees when their booth is dismantled that all trash will be properly disposed of and all banners, signs and other materials used in the operation of the booth will be removed from the area. Occupant must provide the booth's trash receptacles.
4. Any Literature or promotional material (including signs, banners or products offered by the occupant) that is deemed as questionable in character is prohibited. This includes, but is not limited to, literature or products that endorse sexual or deviant behavior; weapons; or any other items deemed questionable by the Okie Noodling Planning Committee.
5. Any violation of this agreement will cause the Okie Noodling Planning Committee to take immediate action if necessary and shut down occupant's booth or prohibit occupant from participating at future Okie Noodling Tournaments.
6. An official Okie Noodling Tournament vendor permit will be provided and must be displayed in a visible location during the tournament. Location will be determined by the Okie Noodling Planning Committee.
